The present document contains the formal undertake of the Bank.....to grant Nuovo Pignone S.p.A. the “Bank guarantee for **warranty period**”.

CONSIDERING THAT

A) - Nuovo Pignone S.p.A., (hereinafter **NP**) by the purchase order n.....(hereinafter **Order**)
.issued on has commissioned to the company(hereinafter
Supplier) the supply of for a total amount of EUR;
and that

B) - The Order, that contain the legal discipline of the above mentioned supply, requires a payment to be made
by Nuovo Pignone S.p.A. in favor of the Supplier for Euro..... equivalent to.....% of the total amount
of the same Order, against presentation of a bank guarantee for the same amount, to be issued by a first-class
bank in favor of Nuovo Pignone S.p.A., as a guarantee of the exact fulfillment by the Supplier of all the contract
obligations relevant **to the warranty clause of** the above mentioned Order

All this considered

THE BANK ACCEPT THE FOLLOWING

1) The undersigned, in his capacity as legal representative, by signing the present document formally and
irrevocably declares that the Bank guarantees on behalf of Nuovo Pignone S.p.A the fulfillment by the Supplier
of all the required contract obligations set forth in the warranty clause of the mentioned Order.

2) As a consequence of the above, the Bank hereby undertakes, without any reservation, to pay NP any sum up
to the maximum amount of Euro..... upon first and simple written request by NP. Such request shall
**be lodged by a Statement, stating that the Supplier has failed to perform the terms of the Order, undersigned
by NP and sent** by Registered Letter.

Such payment shall be executed within and not beyond 10 (ten) business days from receipt of the relevant
request issued by NP.

3) The Bank explicitly declares that the unique condition for payment in favor of NP is the first and simple
request made by the letter with the formalities described in point 2, explicitly exempting NP from presenting any
documentation relevant to the main contract and/or to events for any reasons connected to the execution of the
main contract and/or to contract non-fulfillments that forms the basis of the request for payment. The Bank
therefore, explicitly exempts NP from any obligations of stating or explaining contract' non-fulfillments by the
Supplier (main debtor) forming the basis of the request for payment, or prove them in any ways.

4. The Bank undertakes, in favor of NP, neither to raise any exception nor to promote any action finalized to
prevent or delay the payment of the sums required in execution of the present guarantee obligation, explicitly

exempting NP from any obligation of placing in default and with explicit waiver of any preventive enforcement of the Supplier (main debtor).

5. By the same way the Bank undertakes to pay the sum requested by NP also and independently from any exception raised by the Supplier (main debtor) and/or from any action of any nature that he might undertake, finalized to prevent or delay the payment of the sum due in execution of the present guarantee obligation. For the above purpose, the Bank explicitly declares to waive any exception as for Articles 1945 and 1955 of the Italian Civil Code.

6. The present guarantee is valid for its entire amount until (Indicate the warranty period expiration date) and has to be however considered as automatically extended until the complete Supplier's fulfillment of the warranty contract obligations as required under the Order.

7. In the event of a delay in the payment of the sum required by NP in execution of the present guarantee obligation, the Bank, starting from the registered letter receipt date indicated in Article 2, shall pay interests at the rate indicated in Article 5 of the Law Decree for the execution of Directive 2000/35/CE included any relevant modification and integration.

8. The present document shall be governed, construed, enforced and interpreted in accordance with the laws of Italy.

9. Any dispute arising out of, or in connection with, the present document, including any question concerning its existence, validity or termination, shall be finally resolved by the Tribunal of Florence (Italy), to be considered the sole and exclusive court having jurisdiction with regard to the above mentioned dispute.
