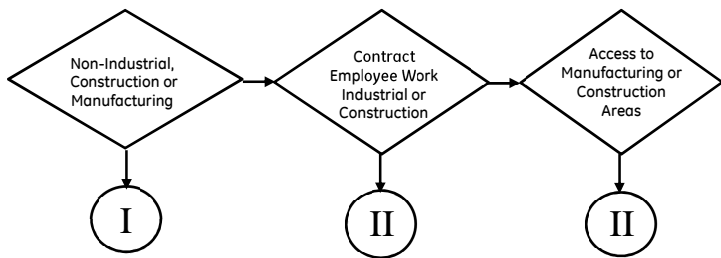


REQUEST FOR ADMITTANCE OF CONTRACTOR PERSONNEL

1. The Project Manager assumes responsibility for:
 - a) Assuring contractor's site issued equipment (including, but not limited to badge, keys and vehicle stickers) are returned prior to contractor employee's departure from site.
 - b) Assures a Nationwide Criminal Background check for each contractor employee has been completed and is available to Site Security if requested. Felony convictions require Security Manager and HR approval for a picture badge. All Foreign Nationals have been properly vetted via Logistics
 - c) Assures contractor has received the appropriate level of training
 - d) Agrees with issuance of picture badge.
 - e) Assuring contract employee assigned SSO (as applicable)
2. Security will require photo identification and proof of citizenship before a badge will be issued.
3. Contractor badge(s) will be issued to an individual who has been a) hired by a GE Sourcing Approved contractor to perform work or services at GE sites and b) approved by Site EHS to perform work on the site.
4. Access level training will be conducted and/or verified by Security prior to issuing a badge
5. Exceptions to be approved by either Site Security or Contractor EHS Manager prior to entry.
